Did you know?

Form IT-2, *Summary of W-2 Statements*, is also enhanced with 2D barcodes. If you file a New York State income tax return and you received federal Form W-2, *Wage and Tax Statement*, you **must** complete fill-in Form IT-2 and submit it with your return.

Do **not** submit your original federal Form W-2 to the Tax Department; keep it for your personal records.
